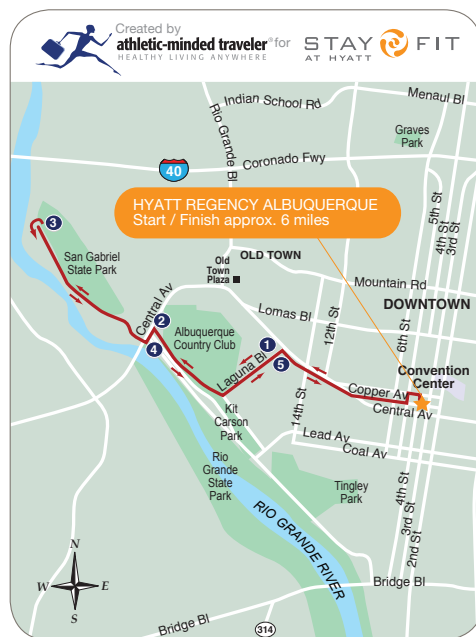
## Enjoy Walking?

## WALKING ROUTE



### Route for Hyatt Regency Albuquerque (Numbers on the map indicate miles)

1. Exit the hotel, head L along Tijeras & turn L at 5th St
2. Turn R at Copper Ave & follow the sidewalk
3. Remain on the sidewalk as it merges onto Central Ave
4. Cross Central Ave at 12th St, then turn L at Laguna Blvd
5. Continue straight past the tennis courts at the end of Laguna
6. Turn R onto the dirt trail & run NW
7. At Central Ave, the dirt trail ends; turn L, cross Tingley Dr & pick up the paved path on the other side
8. Turn R (beneath the bridge) & follow the paved path north
9. Turn around after passing San Gabriel State Park & retrace your steps back to the Hyatt Regency for 6 miles

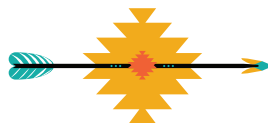
## NAGW Steve Moore Pinnacle Award for Excellence
